From the Survivor Outreach Services Coordinator

Due to the deaths of several service members within the last month, it seemed appropriate to focus on how to obtain military funeral honors when a military loved one passes. It is helpful to know that located at Camp Lincoln is the Casualty Operations Office, which includes the Military Funeral Honors program and the Survivor Outreach Services program. It is also helpful to know that each branch of services performs services only for their own branch. Not too long ago, a family member could request Army Military Funeral Honors for their deceased service member, even if the service member was Air Force, for example. Today, the request can still be made, but it is up to each branch to approve or deny the request. In the pictures located below, you will see contact information for all branches of service. This is good information to keep with your funeral planning documents that family members will use upon your death.

To perform military funeral honors, proof of military service and the type of discharge is an absolute requirement. The easiest proof to obtain is the service member's DD-214. For National Guard Soldiers, an NG-22 is acceptable proof, as well. The information below provides information to obtain proof of military service by contacting the National Archives. A website link is listed, but you may also contact them by phone at 314-801-0800. Another place to check for a DD-214 is the Department of Veterans Affairs. Their website is www.va.gov/records/get-military-service-records/ or, you may call them at 800-827-1000.

As has been mentioned in several columns previously, advanced, end-of-life planning will alleviate the administrative stress at the service member's time of death. Do yourself and your loved one a favor and assemble a packet containing your most current DD-214, how and where you want to be buried, insurance policies, and account numbers for any outstanding debts, banking, and/or investment accounts. For additional assistance in end-of-life planning, after-death assistance for Survivors, and resources for every stage of life, MOAA offers resources on their website. 

ILARNG Military Funeral Honors Program





HONORING THOSE
WHO SERVED

History

The United States Military has a time-honored tradition of honoring their fallen.

On January 1, 2000, Military
Funeral Honors (MFH) became a
statutory benefit to all Veteran's
with the signing of the National
Defense Authorization Act. The
law requires that, upon a family's
request, every eligible Veteran
receive a Military Funeral Honors
ceremony to include, a Two-Soldier
Detail for the sounding of "TAPS",
folding and presenting the United
States Flag.

Mission

The ILARNG provides professional Military Honors in accordance with service tradition to all eligible Veterans when requested by an authorized representative. Soldiers in the ILARNG Military Funeral Honors program are selected and trained using the same standards as Arlington National Cemetery.

Eligibility

An eligible Veteran is any person (Active, National Guard, or Reserve) who has completed at least one enlistment or other obligated military service and received an honorable discharge.

Some of the documents used to determine eligibility include:

- DD-214 (for active duty or reserve component)
- NGB-22 (for National Guard Soldiers)
- Certificate of Honorable Discharge
- General Discharge under Honorable Conditions

Types of Honors

Two Soldier Detail provides a flag fold, presentation and sounding taps for honorably discharged Veterans.

Nine Soldier Detail provides pallbearers, flag fold and presentation, firing party, and sounding taps for a Medal of Honor Recipient, KIA, E-9, or an O-7 and above and any Retiree or an M-Day Soldier who is not serving in a combat situation.

1501 (Memorial) Services provides honors after a funeral has already been conducted

Requesting Honors

A family member or authorized representative is encouraged to notify the funeral director or service coordinator of their desire to have Military Funeral Honors rendered at the interment of their loved one. The funeral director then contacts the appropriate branch of service in which the Veteran served.

Legislative Liaison Update

Advocacy in Action is complete. MOAA members from around the state made contact with all eighteen of our Representatives and both f our Senators. Colonels Roll and Tyler were part of the teams that met with the three Congressmembers representing Lincoln Land's members (R. Davis, LaHood, and Miller). The good news is, most of the Illinois House members have signed on as co-sponsors of the Richard Star Act and they seemed supportive of both the making mental health copays affordable and at least a 4.6% military pay raise for 2023.

The Illinois legislature passed the Medal of Honor Highway (US 20) resolution adding another link to completing that designation from coast to coast. The American Legion will be carrying the Banner across Illinois on route US 20 from the Iowa border to Indiana. Work is progressing on funding and making county Veteran Assistance Commission offices more effective in their support of Illinois veterans. Additionally, the legislature has directed a study to assess the impact of extending the property tax relief for disabled veterans to their surviving spouses.

So, while the Illinois legislature is in recess and Congress is working on next year's Defense Authorization (NDAA), we need to remain vigilant to ensure that the MOAA designated veteran issues make it into the final legislation.

As always, if you get a chance to reach out to your elected official on these topics, do so. Let's *Never Stop Serving!*

Illinois Council of Chapters Reorganization Plans

Col Tyler's discussion with National MOAA on the Reorganization

I told you I was thinking about additional support from MOAA HQ for the Illinois reorganization. And here's my thought and hope that MOAA HQ can support.

- During the workshop at the annual meeting last October, folks asked about the creation of a "speaker's library" of videos available on-line or live streaming for use by Chapters during Chapter meetings.
- In sampling several Illinois members across the state, I am hearing a desire for periodic virtual statewide meetings to connect members and share information.
- I am also hearing my presidents look for ways to connect with folks in population centers within their catchment area.
- I am hearing that folks don't necessarily want to drive 50+ miles for meetings.
- I am exploring Zoom capabilities to:
- o Host large scale virtual meetings
- o Allow multiple "Hosts" on the one purchased account so that Chapters can use the same account for Chapter meetings
- o What I am envisioning is the Council conducts 2 to 4 virtual state wide meetings a year covering important topics basically an information dump prepared by MOAA HQ
- o Pre Advocacy in Action brief on the targeted topics
- o A pre NDAA / Federal budget brief on important "engagement" issues
- o A post A in A brief on how we did
- o An annual update (maybe)
- o Will require state wide e-mail blast announcements from National as we don't have non-chapter members e-mails
- o I am also hearing requests for the capacity to access and share topical presentations at Chapter meetings
- o To be shared on-line during virtual meetings
- o To be projected at live meetings
 - To be projected and also shared on-line at combined live/virtual meetings

So my real "ask" is: Can we develop MOAA HQ virtual support for large virtual presentations? Can we populate some sort of a National MOAA virtual library of topical presentations for chapter use?

MOAA's Legislative Priorities for 2022

- Sustain pay raises and adequate BAH for the troops and COLA raises for retirees.
- Ensure the Coast Guard, National Oceanic and Atmospheric Administration, and Public Health Service continue to receive pay during a government shutdown.
- Protect the value of the military health care benefit.
- Protect the Military Health System pharmacy benefit, and achieve flexibility in TRI-CARE pharmacy copays.
- Address barriers to accessing care within the MHS, including TRICARE coverage gaps and mental health care access challenges.
- Protect family support programs, and ensure military-provided services (housing, PCS, child care, youth programs, financial counseling) are readily available and meet standards for quality and costs.
- Achieve equity of benefits, protections, and administrative support for Guard/Reserve members consistent with their active-duty counterparts.
- Sustain Veterans Health Administration (VHA) foundational missions and services.
- Reform the presumptive process to support veterans claiming service-connected disabilities for toxic exposures.
- Achieve concurrent receipt of service-earned retirement pay and VA disability pay.
- Protect full military honors and burial at Arlington National Cemetery for those currently eligible.
- Improve Survivor Benefits.
- Support a quality transition experience from active duty to veteran status for all servicemembers.
- Recognize the pandemic continues to affect the lives of our servicemembers.

MOAA accomplishments in 2021

- Repealing SBP-DIC offset, known as the 'Widows Tax' saving up to \$12,000 per year for nearly 67,000 surviving spouses.
- Executing a credible game plan for oversight of DoD's health care protecting continued access to quality care.*
- <u>Securing comprehensive privatized military housing reform</u> improving housing, establishing Tenant Bill of Rights, and Congressional oversight.*
- <u>Lessening impact of TRICARE fee hikes</u> (Family = \$300 vice \$900) fighting multiple efforts to end grandfathering for those who entered service before Jan. 1, 2018.*
- Protecting TRICARE For Life (TFL) blocked five consecutive administration budgets proposing TFL enrollment fees (2013-2017).*
- <u>Maintaining pay raise comparability</u> ensuring pay raises for our uniformed services keep pace with civilian sector increases.*
- <u>Providing Wounded Warrior protections and caregiver enhancements</u> securing multiple improvements to VA caregiver programs.*
- <u>Defeating 'COLA Minus 1 Percent'</u> ending Congressional attempts to reduce retired pay, costing an E-7 retiring after 20 years \$83,000, and an O-5 \$124,000, by age 62.*
- <u>Securing major GI Bill upgrades to include transferability</u> and improving benefits for National Guard on Title 32 orders.*
- Boosting compensation significantly for retirees with 50% VA disability still fighting for the rest to include those medically retired.*
- Improving Guard and Reserve TRICARE coverage and securing a premium cut.
- Ensuring Guard and Reserve retirement age credit for active duty service now allowing 90 days to stretch over two consecutive years.

While the association does advocate a strong national defense, it does not, as an association, become involved in matters pertaining to military strategy or individual weapons systems of the various services. The association's board of directors has long believed that such decisions can be made only by those who have all of the facts available to them: today's actively serving military leadership. The association plays an active role in military personnel matters and especially proposed legislation affecting the career force, the retired community, and veterans of the uniformed services. MOAA's overarching goals are captured in its resolutions, which reflect the views of the entire membership. The membership provides input and votes on resolutions every two years (on even years). While MOAA is permitted by law to lobby - and does so actively - its status as a tax-exempt veterans organization precludes it from participating in political activities, which are defined as intervening directly or indirectly in any political campaign on behalf of or in opposition to any candidate for public office. Stated briefly, the association may advocate issues, but it may not advocate the election or defeat of particular candidates or political parties.

- D. The Scholarship Program Award Winner will be contacted not later than July 2022, and the award presentation date will be during the Chapter's Island Bay Yacht Club event.
- E. In satisfaction of the Scholarship Program, Applicant shall attend a meeting or event of a military or veteran's organization or military institution, spending sufficient time with the members of the organization to prepare observations. Following the activity, the applicant will write an essay (see essay requirements below) on that organization or event, and what they learned about the service, sacrifice and commitment of current or former military members to their country. Organizations or events could include the following or similar activities: (Applicant should not attend events or facilities which would cast MOAA in an unfavorable light.)
- 1. Attend drill with a local National Guard or Reserve unit, interacting with unit leaders and others.
- 2. Attend a veteran's discussion group at a local veteran's center.
- 3. Spend time with a college ROTC unit.
- 4. Volunteer at the Illinois Military Museum or similar institution.

- 5. The following items constitute the Applicant's Scholarship Program for Academic Year- Fall 2022 submission. Only those Applicant submissions that contain ALL items listed below will be eligible for consideration:
- 6. The scholarship essay will be type-written on the announced topic and in accordance with the instructions in paragraph E, above. The essay shall contain a minimum of 1,000 words and a maximum of 1,500 words. Applicant shall develop the topic as they deem appropriate, however, the essay must be the original and exclusive work of the Applicant.
- 7. CERTIFICATION of relationship to a Lincoln Land Chapter MOAA Member and Applicant Age. (The enclosure to this announcement shall be used for this purpose.)
- 8. The designation of an institution of higher education that Applicant will be attending in the Fall 2022. Applicant must provide the name and address of the institution of higher education Applicant is, or will be, enrolled in for the Fall 2022 semester (or equivalent).

F. ELIGIBILITY.

- A. An Applicant to this Scholarship Program for Academic Year- Fall 2022 can be a Member or the: spouse; natural, adopted or foster child; stepchild; grandchild; great grandchild or parent of any Member of the Lincoln Land Chapter MOAA. A Member of Lincoln Chapter MOAA is a person who meets the membership requirements specified in Article IV of the Lincoln Land Chapter MOAA Bylaws and who is considered "in good standing" (current in payment of Chapter dues).
- B. Applicant must be at least 18 years of age on or before September 1, 2022.
- C. Applicant must be enrolled in, or accepted for enrollment into an institution of higher education for the Fall 2022 semester (or equivalent) for a minimum of nine semester hours or equivalency. An institution of higher education may be a program, junior college, college, university, technical or trade school, which awards a degree, diploma or certification upon completion of its curriculum. Providing the institution meets the foregoing requirement, the Scholarship Award shall be made without regard to Awardee's academic level. As example, an Awardee may be a Ph.D. candidate, a graduate or undergraduate student, a junior college student, or a student at a trade school. For at least six of the nine qualifying semester hours (or equivalent) Applicant must be scheduled to attend courses in a resident, as differing from on-line (Internet) course enrollment status.
- D. An Awardee may not be considered for another Scholarship Award for five years or until August, 2027.

G. GENERAL INFORMATION.

A. Only essays prepared in Word® can be accepted. Applicant must be prepared to submit an electronic version of their essay at the request of the Scholarship Committee Chairperson.

- B. The Chapter Scholarship Committee will judge essays on the basis of grammar, spelling, topical development and presentation. The essay will be formatted in accordance with the latest Modern Language Association (MLA) guidance.
- C. Essays shall be evaluated using *Harbrace College Handbook* and *Webster's New World Dictionary* as guides. Sources used in the essay must be properly cited.

The Certification page, the enclosure to this announcement, shall be used as the cover page for Applicant essays. No title page or any other form of essay identification shall be used.

- D. Applicant must designate and provide evidence of their acceptance into, or attendance at, an institution of higher education. Items considered to meet this requirement include acceptance letters, recent grade reports, or similar official documents. Based on this information, the Chapter Scholarship Committee shall determine if the residency requirement has been or will be met.
- E. All decisions made by the Chapter Scholarship Committee are final.
- F. All Applicant submissions become the exclusive property of the Lincoln Land Chapter MOAA.
- G. Lincoln Land Chapter MOAA will not be responsible for any delays in receiving Applicant submissions.
- H. If no Applicant essays are received; or if, in the judgment of the Chapter Scholarship Committee, the submissions are inadequate; or if the Scholarship Program Award Winner is later determined to be ineligible for Scholarship Award, the Scholarship Award may be suspended for that Award Year.
- I. The Awardee will be notified in advance, and will be requested to attend, as a guest, a Chapter meeting to be recognized as the Scholarship Program Award Winner.
- J. The Scholarship Program will be given maximum publicity by the Chapter and may include newspaper articles, Award presentation at commencement exercises, notification to school officials and other actions deemed appropriate. Awardee agrees to reasonably participate in such activities.
- K. Any tax liability resulting from an Award shall be the sole responsibility of the Awardee.
- L. In the event circumstances prevent the Awardee from attending an institution of higher education at the beginning of Academic Year-Fall 2022, providing Awardee meets the eligibility requirements in paragraph II C (for any semester equivalent through Spring 2023) the Awardee retains the right to receive this Scholarship Amount.
