## From The Survivor Outreach Services Coordinator Chris Milchuck

Greetings, MOAA Veterans and Family Members! I hope you are well and enjoying this beautiful, spring weather. As in previous columns, I tend to base the information provided on cases with Survivors that come up between columns. Since I have had about half a dozen cases related to assisting Survivors with burial information for their Veterans, I thought it would be good to revisit this topic with a focus on eligibility. Below is information from the Veterans Administration guide about Burial Benefits for Veterans and their Families. A link to the full Burial Benefits Guide in PDF format is available at: https://www.va.gov/survivors/docs/NCAQuickGuideADA.pdf. This guide will help you make burial choices and prepare for the future. Use this guide to learn about these benefits and to avoid making rushed, agonizing decisions at the time of need.

The following are excerpts from the guide for those without the time or ability to download the PDF.

The Department of Veterans Affairs' (VA) and National Cemetery Administration (NCA) offer burial benefits to eligible Veterans, their spouses, and dependent children. These benefits are earned by military service to our Nation and are potentially worth thousands of dollars but are provided at no cost.

A national cemetery burial includes: The gravesite, opening and closing of the grave, a headstone or marker, and perpetual care as part of a national shrine.

Funeral home directors usually arrange for the following benefits by request of the family: A VAprovided headstone or marker for a Veteran buried in a private cemetery anywhere in the world, a burial flag to drape the Veteran's casket or urn during the funeral, a Presidential Memorial Certificate (PMC) honoring the Veteran, and Military Funeral Honors for the Veteran (e.g., burial flag folding and presentation, "Taps" played on a bugle or by recording).

National cemetery directors have the primary responsibility of verifying the Veteran's eligibility for burial in a national cemetery. The Department of Veterans Affairs regional offices (VARO) may also assist.

Those eligible for burial benefits Include:

• Active-duty members who die while serving honorably. Veterans who have served some active duty other than as a Reservist for training and were discharged under other than dishonorable conditions.

• Reservists and National Guard members who, at the time of death, were entitled to retired pay, or would have been entitled had they been over the age of 60.

• Certain National Oceanic and Atmospheric Administration (NOAA) and Public Health Service (PHS) officers and WWII Merchant Mariners.

• Spouses and surviving spouses who meet eligibility requirements.

• Dependent children under age 21, under age 23 if still in school, or of any age If disabled while qualifying in one of the former categories.

• To establish eligibility, you must provide the death certificate and the Veteran's DD Form 214, which shows the Period(s) of Active-Duty Service and Characterization of Discharge

Note: Eligibility requirements were developed over many years through legislation and regulations. This guide does not cover all possible situations for or against establishing eligibility. Contact Call (800) 827-1000 to receive more information. Extensive information is also posted on the National Cemetery Administration's (NCA's) website at: https://www.va.gov/burials-memorials/eligibility/

**Burial Allowances** 

VA burial allowances are flat-rate monetary benefits that are generally paid at the maximum amount allowed by law for an eligible Veteran's burial and funeral costs. Eligible survivors are paid automatically upon notification of a Veteran's death, without the need to submit a claim. If the Veteran had a service-related death on or after September 11, 2001, the maximum burial allowance is \$2,000.

\*There are non-service-related death rates payable if the Veteran was hospitalized by the VA at the time of his or her death:

• If the Veteran died on or after October 1, 2019, VA will pay up to \$796 burial allowance and \$796 for a plot.

• If the Veteran died on or after December 1, 2001, but before October 1, 2011, VA will pay up to \$300 burial allowance and \$300 for a plot.

• An annual increase in burial and plot allowances for deaths occurring after October 1, 2011 began in fiscal year 2013 based on the Consumer Price Index for the preceding 12-month period.

Veterans, to make things easier for your family members, advise them of your wishes ahead of time and tell them where your discharge papers are kept. These papers are very important in establishing your eligibility. At the time of need, your family will contact a funeral home, who will assist them with making burial arrangements at the national cemetery. You may wish to make pre-need arrangements with a funeral home.

Surviving family members:

To schedule a burial, fax all discharge documentation to the National Cemetery Scheduling Office at 1-866-900-6417 and, follow-up with a phone call to 1-800-535-1117.

For cremation or burial expenses: The VA does not pay for cremation directly. Any item or service obtained from a funeral home will be at the families' expense. However, some Veterans' families may be entitled to a burial allowance, which may cover some of these expenses.

For burial at sea: The VA does not provide burial at sea. If you have any questions about the Burial at Sea program, please contact the United States Navy Mortuary Affairs office toll-free at 1-866-787-0081.

#### From The Chapter Chaplain

On July 29, we will commemorate the 248th year since the birth of the Army Chaplain Corps. Older even than the United States, the Chaplain Corps was—and is— integral to the fabric of our nation, and instrumental to our military's success. As we prepare to mark this historic milestone, let's take a look at the story of how the Chaplain Corps' was formed.

In the summer of 1775, the Second Continental Congress convened in Philadelphia. Though members of the Congress would not sign the Declaration of Independence for another year, the colonies were already engaged in a difficult and bloody war against the most powerful military in the world, Great Britain.

But they were determined to stand up for their God-given rights.

With violence escalating and the war becoming even more gruesome, Congress commissioned George Washington as Commander in Chief of the Continental Army. Less than a month after taking charge, Washington made one of his first requests, something he knew would be a vital and necessary component for his military operation.

As a military commander, Washington anticipated the toll war would take on his troops, especially knowing the incredible effort on the part of the colonists to defeat a formal standing army. Of course, he knew how important it was for his soldiers to be physically prepared, but he also understood that he would need something more in the face of such odds: spiritual fortitude, and the moral strength to persevere.

Though many ministers were already volunteering alongside colonial troops, Washington wanted their services recognized and financially compensated, and for them to become an official part of the army.

On July 29, 1775, Congress granted Washington's request and the Chaplain Corps was born. There would be one chaplain for each regiment in the Continental Army. Receiving a captain's pay, they would attend to the spiritual, emotional, and even physical wellbeing of the troops.

Since the inception of the Corps, chaplains have served in every American war. Though the Army Chaplain Corps is the oldest branch of its kind, the Navy and Air Force later established their own chaplaincy programs. Throughout American history, over 400 military chaplains have died in war, sacrificing their lives for their troops, many of them receiving recognition for their valor.

Today, chaplain's corps have withstood the test of time as a valuable asset and a necessary institution critical to each branch of the U.S. military.

In addition to looking after the spiritual wellbeing of military troops, chaplains are tasked with upholding religious freedom, ensuring that the individual beliefs of military members are respected. Today, a diverse and expanding group of religions are represented among military chaplains, ranging from majority faiths like Christianity to minority religions like Judaism and Buddhism.

Regardless of a service member's personal religious beliefs, faith continues to be a source of strength, comfort and inspiration for those who risk life and limb to defend our most cherished freedoms. As First Liberty Institute client and retired Navy Chaplain Wes Modder put it, "when people come into the military, they don't leave their faith, they bring their faith with them."

The legacy of promoting and protecting spiritual fitness for America's troops is older than America itself. It's a part of our country's heritage, and today we ought to embrace that legacy, which continues to inspire thousands of courageous men and women to serve our country in uniform.

## Legislative Liaison Update

It was good to be back in person in DC on April 26th for MOAA's annual Advocacy in Action 2023 event. The Illinois team consisted of CAPT Jim Murphy, who covered the two senate offices, while COL Bob Tyler & Kimberly Bruce (MOAA staff); and Col Richard Smith & Fahria Hossain (MOAA staff) visited the House of Representatives offices.

April 26th was a busy day on the Hill as many of the representatives were in and out of their offices, either on the "floor" for voting or in committee meetings. Because of the floor vote to raise the debt ceiling we were only able to meet with three of the eight principles we were scheduled to visit: Congresswoman Jan Schakowsky (D-IL-09), Congressman Bill Foster (D-IL-11), and Congressman Jonathan Jackson (D-IL-01).



We presented the three AiA issues: Restoring BAH to 100%; Restoring the TriCare pharmacy network; and general Support for the All-Volunteer Force to the congressional staff members for the remaining congressional offices.



I was able to meet with staff members for the Illinois districts within the Lincoln Land Chapter's area. From previous visits with Congressman LaHood, I knew he enjoyed snacking on Beer Nuts that are made in Bloomington-

Normal, so for the fun of it, I gave his staffer, Austin Welter, a package of Beer

Nuts to share with the Congressman.

And we had a very good and lengthy visit with Dominick Namias from Congresswoman Mary Miller's office. It was a very good day on the Hill, but our work is not done.

The Scholarship Program Award Winner will be contacted not later than July 2023, and the award presentation date will be during the Chapter's Island Bay Yacht Club event in August 2023.

In satisfaction of the Scholarship Program, Applicant shall attend a meeting or event of a military or veteran's organization or military institution, spending sufficient time with the members of the organization to prepare observations. Following the activity, the applicant will write an essay (see essay requirements below) on that organization or event, and what they learned about the service, sacrifice and commitment of current or former military members to their country. Organizations or events could include the following or similar activities: (Applicant should not attend events or facilities which would cast MOAA in an unfavorable light.)

Attend drill with a local National Guard or Reserve unit, interacting with unit leaders and others.

Attend a veteran's discussion group at a local veteran's center.

Spend time with a college ROTC unit.

Volunteer at the Illinois Military Museum or similar institution.

Attend a military or other military-related ceremony and interview people present.

The following items constitute the Applicant's Scholarship Program for Academic Year- Fall 2023 submission. Only those Applicant submissions that contain ALL items listed below will be eligible for consideration:

The scholarship essay will be type-written on the announced topic and in accordance with the instructions in paragraph E, above. The essay shall contain a minimum of 1,000 words and a maximum of 1,500 words. Applicant shall develop the topic as they deem appropriate, however, the essay must be the original and exclusive work of the Applicant.

An Applicant to this Scholarship Program for Academic Year- Fall 2023 can be a Member or the: spouse; natural, adopted or foster child; stepchild; grandchild; great grandchild or parent of any Member of the Lincoln Land Chapter MOAA. A Member of Lincoln Chapter MOAA is a person who meets the membership requirements specified in Article IV of the Lincoln Land Chapter MOAA Bylaws and who is considered "in good standing" (current in payment of Chapter dues).

Applicant must be at least 18 years of age on or before September 1, 2023.

Applicant must be enrolled in, or accepted for enrollment into an institution of higher education for the Fall 2023 semester (or equivalent) for a minimum of nine semester hours or equivalency. An institution of higher education may be a program, junior college, college, university, technical or trade school, which awards a degree, diploma or certification upon completion of its curriculum. Providing the institution meets the foregoing requirement, the Scholarship Award shall be made without regard to Awardee's academic level. As example, an Awardee may be a Ph.D. candidate, a graduate or undergraduate student, a junior college student, or a student at a trade school. For at least six of the nine qualifying semester hours (or equivalent) Applicant must be scheduled to attend courses in a resident, as differing from on-line (Internet) course enrollment status.

An Awardee may not be considered for another Scholarship Award for five years or until August, 2027.

The Awardee will be notified in advance, and will be requested to attend, as a guest, a Chapter meeting to be recognized as the Scholarship Program Award Winner.

The Scholarship Program will be given maximum publicity by the Chapter and may include newspaper articles, Award presentation at commencement exercises, notification to school officials and other actions deemed appropriate. Awardee agrees to reasonably participate in such activities.

Any tax liability resulting from an Award shall be the sole responsibility of the Awardee.

In the event circumstances prevent the Awardee from attending an institution of higher education at the beginning of Academic Year-Fall 2021, providing Awardee meets the eligibility requirements in paragraph II C (for any semester equivalent through Spring 2023) the Awardee retains the right to receive this Scholarship Amount.
